New Business

A. Review proposed 2020/2021 Tentative Budget

GENERAL BUDGET

1. Tax Levy – Increase levy from \$453,669 to \$462,852 totaled \$9,183

2018 Taxable Assessed Value per \$1000 = \$10.586572 (\$42,013,030) 2019 Taxable Assessed Value per \$1000 = \$10.514617 (\$43,146,506) 2020 Taxable Assessed Value per \$1000 = \$10.561141 (\$43,825,945)

Administrator Wood stated the current tax increase allowed is 2.02% as researched on New York State Comptroller's Webpage. Concerns of exceeding the 2% tax cap were stated and discussed by Board members thoroughly.

MOTION was made by Mayor Morgan to reduce the tax levy increase to 2% and seek additional guidance from New York State Comptroller as to final tax rate allowed by law and to present any findings prior to final budget adoption at the April 2020 Village Board Meeting, seconded by Trustee Allen. Carried 4-0.

BE IT RESOLVED that the Nunda Village Board of Trustees approve the 2020/2021 Tentative Budget as presented with the following Appropriations: General Fund \$626,555.00 with \$462,852.00 to be raised by Taxes, Sewer Fund \$248,458.00, Water Fund \$330,282.00 and Youth Recreation \$20,593.00. Such budgets include the Mayor's salary of \$2,000.00; Deputy Mayor \$2,500.00; and three Trustee positions at \$2,200.00 each – totals annual compensation;

AND FURTHERMORE, BE IT RESOLVED, a Public Hearing on the budget adoption to be held on Tuesday, April 14, 2020 at 6:30 PM.

The **motion** was made by Trustee Wilcox, seconded by Trustee Allen. Carried 4-0.
